I. Context

Within this project is developed **Activity 4** : “Streamlining Descriptor’s D1 selected criteria regarding mammals species groups (*small toothed cetaceans, deep diving toothed cetaceans and baleen whales*) towards coordinated monitoring and assessment in the Mediterranean region” (*Leader: ACCOBAMS Secretariat*)

And within this Activity 4 is developed the **Task 4.4** : “Complementarity of results from different large-scale monitoring platforms” (*Leader: EcoOcean Institut*), including three steps, **this meeting being part of the step 1** :

1- Review and compare large scale methodologies and analysis to address D1C2 (abundance) and D1C4 (distribution)

⇒ a **SWOT analysis** : take into account the capacity of each method to answer the MSFD criteria in a clear and simple way, their robustness and precision and their reproducibility. Finally, a focus will also be made on their possibility to compare their resulting outputs in order to detect changes (trends).

⇒ **relevant experts** having developed or used as a routine some of these methodologies will be contacted and asked to participate in a **working group** (*exchanges, review of the SWOT plan and final document*).

2 - Select and adapt an appropriate existing method of geostatistic to evaluate and optimise the analyses of existing datasets gathered from different monitoring schemes.

3- develop a methodological framework for the evaluation of the status of cetacean populations distribution and abundance, proposing practical recommendations for the implementation of indicators for the relevant criteria.
