# Face-to-face meeting of the Working group on cetacean monitoring under MSFD in the scope of the ABIOMMED project

Rome, 14-15 June 2023

## 1. Context and background

The ABIOMMED project – "SUPPORT COHERENT AND COORDINATED ASSESSMENT OF BIODIVERSITY AND MEASURES ACROSS MEDITERRANEAN FOR THE NEXT 6-YEAR CYCLE OF MSFD IMPLEMENTATION" is an EU research project funded under DG EN9/M6FD 2020 CALL with the main purpose to support the competent authorities of the Mediterranean region, as well as the UNEP/MAP for a (sub)regional cooperation for the preparation of the next 6-year cycle of MSFD implementation. The project is implemented in cooperation between 17 partners, intergovernmental organizations, national authorities, research centres, institutes and other expert organizations. Project duration covers 2021 – 2023 period.

SUPPORT COHERENT AND COORDINATED ASSESSMENT OF BIODIVERSITY AND MEASURES ACROSS MEDITERRANEAN FOR THE NEXT 6-YEAR CYCLE OF MSFD IMPLEMENTATION The project consists of 6 activities, focussing on GES assessment of pelagic, benthic habitats, cetaceans, integration of GES biodiversity assessment in a pan-Mediterranean scale and socio-economic analysis of measures.

The GES assessment of cetaceans is analysed under the *Activity 4: Streamlining Descriptor's D1 selected criteria regarding mammal's species groups (small toothed cetaceans, deep diving toothed cetaceans and baleen whales) towards coordinated monitoring and assessment in the Mediterranean. Activity 4 Partners are: ACCOBAMS Secretariat (Activity coordinator), EcoOcean Institute, CoNISMa, ISPRA and Tethys Research Institute. These partners have been in charge of preparation of technical documents (deliverables) that will be presented in the meeting, including revision of different elements of the MSFD related to cetaceans, definition of threshold values, spatial distribution modelling related to criteria D1C4 (Population distributional range and pattern) and D1C5 (Habitat for the species), analysis of complementarity of results of different cetacean monitoring platforms to relevant MSFD criteria, as well as assessment of potential factors of uncertainty on large-scale synoptic surveys (for more information see: List of documents).* 

In the scope of Task 4.1. "Strenghten regional coordination on cetacean monitoring", a Working Group was established, composed of researchers, managers and experts from all Mediterranean and Black Sea EU countries, in charge of the definition/implementation of their country's MSFD cetacean monitoring programme. The task of this Working Group was to facilitate preparation of deliverables. A key step in implementation of Activity 4 is organization of the face-to-face meeting of the Working Group in June 2023. The Italian ISPRA agreed to host the meeting at its premises in Rome.

## 2. Venue, date and language of the meeting

## 3. Objectives of the meeting

The objectives of the meeting are:

- to review different deliverables prepared by Activity 4 project partners and to prepare common recommendations, in particular regarding definition of threshold values for MSFD D1 cetacean related criteria,
- to facilitate regional coordination and exchange of information between the EU and non-EU countries, in particular in the context of the Ecosystem Approach (EcAp) lead by UNEP/MAP.
